



Dear Camper and Parents,

Summer Camp preparations have begun at SRCC. This packet has been designed to give you as much information as possible about MIX, hopefully answering any questions you may have.

From **June 2-6**, our 6-8 graders are attending MIX, a weeklong camp designed by Christ In Youth (CIY) specifically for middle school students. We will still be traveling to the Windermere Conference Center in Lake of the Ozarks, MO. The cost for each student is \$300 if you register by the **early bird date of April 24** or \$350 after that time (if there is still space at the camp too). To reserve a spot for camp, you will need to turn in a **\$100 NON-REFUNDABLE deposit** (checks made to SRCC), our SRCC Release Form, and the CIY Medical Release Form.

\*\*\*Currently, we have a total of 60 spaces reserved, and the spots are first come first serve. The camp is close to filling up, though we may be able to get additional spots if some open up. However, the quicker you turn in your forms and deposit, the better the chance that one of those spots goes to your child. Our goal is to take everyone who registers!

## What to Bring

- A fantastic attitude and a desire to draw near to God
- Casual clothing for 4 days → wear our color (shorts that meet our standards and pants are acceptable for all meetings & worship)
- Swimwear and sleepwear

## Frequently Asked Questions

**Q: What is MIX?**

**A:** MIX is a four-day summer event that provides all of the tactile, interactive, small group faith-building experiences of a Christ in Youth event. MIX is not designed for high-schoolers or preteens, but is specifically designed for 6th, 7th and 8th graders and their special cognitive and developmental abilities. Adults build relationships with students as they come to understand their own spiritual formation and grow as Kingdom workers through dynamic worship, engaging activities, off-the-chart recreation and small group interaction.

**Q: Why do a Middle School-only event?**

**A:** Middle school students are at a unique moment in their lives. They're growing and learning differently than any other age group. They're still young enough to need to play, but they're old enough to start grabbing onto some core ideals that will stay with them the rest of their lives. MIX gives these students the chance to have fun and enjoy spending time with their peers, while also challenging them with age-appropriate ideals that will help them embrace Christ's call on their lives to be Kingdom Workers.

**Q: What is the theme for this year's MIX?**

**A:** This year, the theme is "To Be Continued." Elijah laid on a desert floor ready to give up. He had seen God do great things, but those felt like distant memories. Where was God when he was in danger, when he needed Him most? In the midst of those questions, Elijah was about to have a life-altering, history-changing encounter with the Creator of the Universe. He just had to stand up and continue walking toward a divine appointment with God. Elijah was one of the greatest Kingdom workers in all of Scripture, but he also passed his faith along to other Kingdom workers so that they, too, could continue advancing the Kingdom. At MIX, students will be invited you to dive into the life of Elijah and learn what it means to continue standing up for God in a world that denies Him, to continue pressing on when all seems lost and to continue the call from God that has been given to each of His children since the dawn of time.

**Q: Are there any fundraising opportunities to offset the cost of MIX?**

**A:** Yes. We have a couple opportunities. We will have be having a dodgeball tournament that is scheduled for Sunday, April 14<sup>th</sup>, a "Walking Tacos and Bake Sale" on Sunday, April 28, and a "Rent-A-Student" during April-June. Watch the bulletin, website, youth emails, and service video announcements for information. (We will also put that info on Facebook since some emails aren't going through.)

**Q: What does the "Wear Our Color" mean in the What to Bring section?**

**A:** One of the ways CIY makes MIX fun is a weeklong competition between teams. Every church at MIX is placed into one of four teams, and those groups are recognized by a color. When Andy finds out what color our team is, he will let you know, and we can represent our team well by wearing that color.
